



ROCK WALL WAIVER AND RELEASE

I hereby acknowledge the inherent extreme risk in rock climbing, including on artificial surfaces. I realize that those risks include, but are not limited to: falls from or contact with walls and equipment, bad decision making, inattention of belayers or actions of other climbers, misuse or failure of equipment, holds which may become loose or damaged and freakish accidents which cannot be foreseen.

I acknowledge that the above list is not inclusive of all possible risks associated with the use of the facilities, and/or the sport of climbing and I agree that said list in no way limits the extent or reach of this release. I voluntarily assume all risks for said minor(s) and I with full knowledge and appreciation of the danger and risk involved.

I voluntarily agree to assume all risk of personal injury to said minor(s), whether or not under supervision of Zero Gravity personnel. I hereby knowingly and intentionally waive and release, and agree to indemnify, hold harmless and defend Zero Gravity Unlimited, Inc., its successors, assignees, officers, employees, and wall designers and builders, hold manufacturers, lessors, affiliated organizations and agents from all liability for any such damage, injury, paralysis, or death which may result. This release shall be effective even though said loss, damage or injury results or has resulted from the negligence, wrongful acts, omissions, breach of warranty or strict tort liability of Zero Gravity or the other parties released.

(Zero Gravity) to climb at its facility, portable wall and/or participate in any program offered by Zero Gravity Unlimited, Inc., including its climbing school, I agree to the following waiver and release and make the following representations on their behalf:

I understand that this release is a legally binding contract. No oral representation, statements or inducements apart from the above written agreement have been made. I expressly state that I have read, understand and am familiar with all its provisions and that I sign of my own free will. I further expressly agree that this release, waiver and indemnification agreement is intended to be as broad and inclusive as is permissible by the laws of the state of Texas and that if any portion of this agreement is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. Should Zero Gravity Unlimited, Inc. or anyone acting on their behalf, be required to incur attorney fees or cost to enforce this agreement, I agree to indemnify and hold harmless from such fees and costs.
