NOTICE TO SPECIALTY CONCRETE CONTRACTORS

Under the terms of the MEMORANDUM OF AGREEMENT COVERING SPECIALTY CONCRETE CONSTRUCTION (EXCLUDING ALL OTHER CONSTRUCTION), the Wage and Fringe Benefit Rates effective **July 1, 2021** apply as follows:

Hourly Rates for Podium Work, Podium Wrap Work, Flat Plate Parking Structures:

Pre-Entry to General Labor Tenders**

**Effective
July 1, 2021**

Base Wage	\$18.00
Vacation (Supplemental Dues \$0.75)	0.75

** In the event the non-payment of a Health and Welfare contribution for the first 600 hours of employment violates the provisions of the Affordable Care Act, the Employer shall be required to make such contributions at the rate for the General Labor (Tender) Classification so as to comply with the Act.

Hourly Rates for Mid-Rise Construction subject to the MOA provisions:

Light Commercial Agreement and General Construction Worker rates negotiated as part of the MLA, however the Health & Welfare Trust Fund on behalf of the General Construction Worker shall be the same as the rate for the classification contained in the "General Labor (Tender)" Classifications. General Construction Workers shall perform only those duties within the scope of the classification.

Foreman:

Foreman	\$1.75 per hour over the highest paid Journeyman
General Foreman	\$2.75 per hour over the highest paid Journeyman

All Foremen shall be selected by the Employer including the number that may be needed.
