An understanding and willingness to work or interact with high-risk juvenile residents in the institution and/or assigned to work experience in the MYC Food Service Unit is needed. In the latter, the incumbent trains/instructs, assigns work, sets task priorities, checks quality of work and evaluates performance of juvenile residents.

JOB DESCRIPTION:

This position is located in a twenty-four-hour facility and must be able to work a non-standard workweek to include working holidays and various shifts. This position is responsible for planning, preparing, and serving meals at McLaughlin Youth Center (MYC), serving approximately 150 meals per meal period. This position prepares raw foods; cuts meats; cooks by baking, frying, sautéing, broiling, steaming, and grilling; serves food; and cleans and washes equipment/kitchen area. In addition, this position is responsible for the training and supervision of juvenile residents working in the kitchen. The incumbent must follow all MYC, State, and Federal regulations and policies.

SPECIAL REQUIREMENTS

The position requires essential skills and knowledge in the preparation of meals to serve the staff and residents of MYC. This person must obtain the minimum required training for all employees at MYC. This includes but is not limited to CPR and First Aid. The incumbent must possess and maintain a valid Alaska Driver's License. Essential physical requirements of the position include the ability to stand for extended periods of time and work in hot and/or cold environments.

THIS POSITION REQUIRES THE INCUMBENT TO OPERATE

Commercial or institutional grade food preparation equipment such as floor mixer, blender, deep-fat fryer, grill, oven, beverage dispenser, etc.
