RE: **Increase in Fringe Benefits and Wages**
Effective June 1, 2019 through May 31, 2020

Under the terms of your collective bargaining agreement with the Construction and General Laborers' District Council of Chicago and Vicinity, there is an overall increase of **\$2.31 effective June 1, 2019.**

The base wage rate will increase by **one dollar (\$1.00) to \$43.72** per hour.
The Welfare contribution will increase by **twenty-eight cents (\$0.28) to \$14.05** per hour worked.
The Pension contribution will increase by **eighty-five cents (\$0.85) to \$14.55** per hour worked.
The Training contribution will increase by **eighteen cents (\$0.18) to \$0.90** per hour worked.

Therefore, the following base wage, fringe benefit rates, and work dues deduction are effective June 1, 2019:

BASE WAGE	\$43.72 per hour worked
WELFARE FUND	\$14.05 per hour worked
PENSION FUND	\$14.55 per hour worked
TRAINING FUND	\$ 0.90 per hour worked
LECET*	\$ 0.07 per hour worked
LDCLMCC**	\$ 0.17 per hour worked
 WORK DUES DEDUCTION	 3.75% of gross wages

All other Industry Fund contributions remain unchanged.

Under the terms of your collective bargaining agreement with the Construction and General Laborers' District Council of Chicago and Vicinity, there is an overall increase of **\$2.31 effective June 1, 2019.**

The base wage rate will increase by **one dollar (\$1.00) to \$43.72** per hour.
The Welfare contribution will increase by **nine cents (\$0.09) to \$14.99** per hour worked.
The Pension contribution will increase by **one dollar and four cents (\$1.04) to \$13.61** per hour worked.
The Training contribution will increase by **eighteen cents (\$0.18) to \$0.90** per hour worked.

Therefore, the following base wage, fringe benefit rates, and work dues deduction are effective June 1, 2019:

WELFARE FUND	\$14.99 per hour worked
PENSION FUND	\$13.61 per hour worked
TRAINING FUND	\$ 0.90 per hour worked
LECET*	\$ 0.07 per hour worked

 WORK DUES DEDUCTION	 3.75% of gross wages
