Plow trucks, dump trucks, sanders, boiler trucks, loaders, dozers, rollers, forklifts, water trucks, sweepers, asphalt equipment, brush cutters, tar pots, pickups, hand and power tools, welding and fabricating equipment, and other heavy equipment assigned.

JOB DESCRIPTION:

As part of a maintenance crew, this position performs various tasks associated with the year-round maintenance of state highways and airports within the District. The work includes, but is not limited to operating and servicing heavy and light-duty equipment, maintenance of all vegetation, signs, barricades, fences, bridges, culverts and drainage structures, bike paths and road surfaces within the State Right-of-Way as well as performing traffic control duties including flagging. Performs all duties and operates all equipment required by an Equipment Operator (J1) wage grade 54. This level operates smaller or non-specialized (light duty) motorized equipment such as dump truck with a single or no attachment.
