



Park Rules and Regulations

The El Pomar Youth Sports Park is intended for Youth Activities. Adult leagues will be permitted with permission if there are vacant fields from youth activities.

Only Colorado Springs Parks and Recreation personnel are authorized to perform any maintenance tasks on any baseball, softball, soccer, or lacrosse fields.

You are responsible for your group and/or parties actions and conduct during your reservation. Your current and future reservation requests may be cancelled if the following should occur: Fighting; Unseemly conduct; Health Violations (spitting, smoking, etc.); Abuse of staff or property; Negligent or delinquent in remitting payment.

All teams aged 11 and older must reserve a minimum of 90 minute practice time, unless constrained by daylight savings or written permission is obtained by El Pomar Youth Sports Park personnel.

Vending (including food, drinks, and sports related merchandise) is not allowed on the complex property unless written permission is obtained from El Pomar Youth Sports Park personnel and a proper vender registration form is completed.

All cars must be parked in designated parking areas. Vehicles located in fire lanes or handicapped spaces will be towed at the owner's expense.

El Pomar Youth Sports Park is not responsible for damage or theft to cars parked on the property. Vehicles must park at their own risk.

Any use of amplified sound equipment must be in compliance with City Code, Chapter 21.

A \$100 refundable deposit is required at the time of the booking.

Groups must provide at least 72 hours notice of cancellation of their booking. We reserve the right to partially refund deposits when cancellation occurs less than 72 hours of original reservation. No Shows will be charged 50% of the deposit refunded.

Contract changes/cancellations will only be accepted from the individual originally booking the facility(s).

Your group must assume responsibility for providing adequate supervision, facility cleanliness and general order while using the facility.

Alcoholic beverages are strictly prohibited.

Damage and/or destruction of the above named property(s) will result in repair and/or replacement fees billed directly to you.

In all circumstances, the Organization retains full authority for final approval and denial of facility reservation requests.

The undersigned must present to the El Pomar Youth Sports Park, prior to the start of activity, a certificate of insurance in the amount of \$100,000 property damage and \$300,000 personal injury liability insurance with El Pomar Youth Sports Park listed as additional insured.

WAIVER STATEMENT

The undersigned stated that he/she on behalf of his/her organization, league or team understands the El Pomar Youth Sports Park and the Colorado Springs Youth Sports, Inc. is not and shall not be responsible for or liable for any illness, or injury to person or damage to property resulting from the program in which the undersigned is enrolled or being enrolled or from his/her participating in said program, and the participant and the undersigned, if the participant is a minor or under other legal disability, hereby forever releases and holds harmless the said Colorado Springs Youth Sport, Inc. and El Pomar Youth Sport Park, its employees, agents, and representatives from any and all claims of any kind that the participant, or the undersigned, or the irrelative heirs, executors, administrators, or assigns may have or claim to have resulting from participant in said program. The undersigned agrees to obtain the written consent of the guardian of any minor or incompetent participant if requested by the El Pomar Youth Sports Park or the Colorado Springs Youth Sports, Inc. Also, the undersigned and the participants authorize the Colorado Springs Youth Sports, Inc., and/or El Pomar Youth Sports Park to use at its discretion any photograph(s) (black, white or color) taken of the participant while participating in the program and waive any and all claims that the participating or undersigned or their heirs, executors, administrators, or assigns may have or claim to have resulting from such photograph(s) or reproductions thereof. The Colorado Springs Youth Sports, Inc. and El Pomar Youth Sports Park carries no insurance for players, coaches or spectators. The Emergency Medical Services will be called for any medical emergencies. Parents are responsible for any and all fees resulting from a medical emergency.
