Information We May Collect

We may ask you for a variety of information, including but not limited to:

- Contact information such as name and/or email address.
- Any information you provide through activity such as online job applications or user inquiries.

We may also utilize tracking tools to determine your location (City and State).

How We Collect Information

We may collect information from you through forms that you fill out yourself through actions including but not limited to applying for a job online or entering a promotional contest online.

We may also utilize tools such as browser cookies and/or web beacons to collect information.

We may utilize third parties including but not limited to our business partners or social media platforms to collect information from you.

How We Use the Information We Collect

To better communicate with you regarding any inquiries or feedback you submit online, your information may be used when crafting and delivering responses. We may also use your information for security purposes, including allowing for the protection of our company, customers or website.

We might use your information to serve you ads about products and offers, which may consist of but are not limited to third party offers or products we determine to be of possible interest to you. We may also use your information to keep you informed about new features that are available or new updates that have taken place.

Your Information May Be Shared

We may share your information with third parties operating and/or performing maintenance on our website. We may also share information with third parties that play a role in carrying out a promotion or contest on our behalf.

We may share information with third parties to facilitate marketing efforts. These third parties may include but are not limited to our retail partners or entities offering products or services we determine to be of possible interest to you. We may share information with a successor to all or part of our business.
