LUNCH:

All Full-Day Campers should bring a bag lunch each day. A beverage and snack will be provided. The State of Maryland recommends that lunches be kept at 45 degrees to keep food from spoiling. We encourage you to pack your child's lunch in an insulated lunchbox with an ice pack. The Studio does not provide refrigeration for lunches.

PAYMENT:

Tuition is made in two (2) payments. The first payment is a 25% non-refundable, non-transferable deposit due upon registration. The remaining balance must be paid three (3) weeks prior to the first day of camp. There will be a \$35 charge for all returned checks. Both parents are responsible for payment.

CHANGES OF CONTRACT:

Any changes in the weeks registered on this contract must be made in writing three (3) weeks prior to the first day. Thereafter you are liable for all weeks registered.

In the event your child loses more than three (3) consecutive days of absence because of medical reasons, a tuition refund will be made for each day lost AFTER the three (3) day deductible period. A doctor's note must be presented to receive a refund. Refunds will not be made for any other reason.

Backstage reserves the right to cancel classes or camps due to lack of enrollment. Class times subject to change.

I give my permission for my camper to participate in any and all activities of the camp, and any trips made away from camp.
