## SECTION 4. FIRST AID MEASURES

**Ingestion(Swallowing) :** No treatment is necessary under ordinary circumstances. Do not induce vomiting. This material does not present any known ingestion hazard

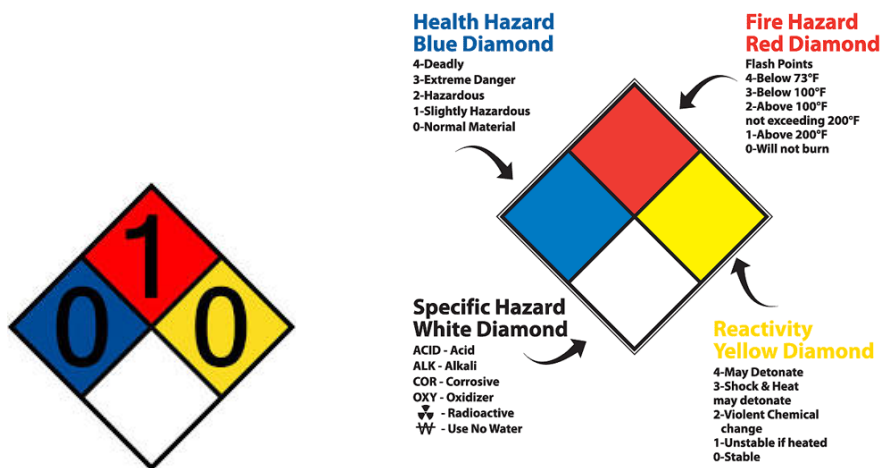
**Most important symptoms and effects, both acute and delayed:** Dry skin and possible irritation with repeated or prolonged exposure. Inhalation of oil mists or vapors generated at elevated temperatures may cause respiratory irritation. Accidental ingestion can result in minor irritation of the digestive tract, nausea and diarrhea.

**Notes to Physician:** Acute aspirations of large amounts of oil-laden material may produce a serious aspiration pneumonia. Patients who aspirate these oils should be followed for the development of long-term sequelae. Inhalation exposure to oil mists below current workplace exposure limits is unlikely to cause pulmonary abnormalities.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

**Protective Measures:** Eliminate all sources of ignition in vicinity of spilled material.

**Accidental Release Measures :** Stop the source of the leak or release. Clean up releases as soon as possible, observing precautions in Exposure Controls/Personal Protection. Contain liquid to prevent further contamination of soil, surface water or ground-water. Clean up small spills using appropriate techniques such as sorbent materials or pumping. Where feasible and appropriate, remove contaminated soil.

## SECTION 7. HANDLING AND STORAGE

**Precautionary Measures:** Do not get in eyes, on skin, or on clothing. Keep out of the reach of children. Wash thoroughly after handling.

**General Handling Information:** Avoid contaminating soil or releasing this material into sewage and drainage systems and bodies of water.

**Static Hazard:** Electrostatic charge may accumulate and create a hazardous condition when handling this material. To minimize this hazard, bonding and grounding may be necessary but may not, by themselves, be sufficient. ### PERSONAL PROTECTIVE EQUIPMENT

**Eye/Face Protection:** No special eye protection is normally required. Where splashing is possible, wear safety glasses with side shields as a good safety practice.

## SECTION 10. STABILITY AND REACTIVITY

**Reactivity:** This material is not expected to react.

**Possibility of hazardous reactions:** Hazardous reactions not anticipated.

**Chemical Stability:** This material is considered stable under normal ambient and anticipated storage and handling conditions of temperature and pressure.

**Incompatibility With Other Materials:** May react with strong acids or strong oxidizing agents, such as chlorates, nitrates, peroxides, etc.

## SECTION 12. ECOLOGICAL INFORMATION

**GHS Classification** : No classified hazards

**Toxicity:** Acute aquatic toxicity studies on samples of lubricating base oils show acute toxicity values greater than 100 mg/L. These tests were carried out on the water accommodated fraction. Results are consistent with the predicted aquatic toxicity of these substances based on their hydrocarbon composition. Classification: No classified hazards.

**Persistence and Degradability:** Highly refined base oils are complex combinations of individual hydrocarbon species. Based on the known or expected properties of individual constituents, category members are not predicted to be readily biodegradable. Some hydrocarbon constituents of highly refined base oil are predicted to meet the criteria for persistence; on the other hand some components can be easily degraded by microorganisms under aerobic conditions.

**Bioaccumulative Potential:** Log Kow values measured for the hydrocarbon components of this material range from 4 to over 6, and therefore would be regarded as having the potential to bioaccumulate. In practice, metabolic processes may reduce bioconcentration.

**Mobility in Soil:** Volatilization to air is not expected to be a significant fate process due to the low vapor pressure of this material. In water, these base oils will float and spread over the surface at a rate dependent upon viscosity. In soil and sediment, hydrocarbon components will show low mobility with adsorption to sediments being the predominant physical process. The main fate process is expected to be slow biodegradation of the hydrocarbon constituents in soil and sediment.

Other Adverse Effects: None anticipated.

## SECTION 13. DISPOSAL CONSIDERATIONS

Disposal recommendations based on material as supplied. Therefore, it may be disposed of as an industrial waste in a manner acceptable to good waste management practice and in compliance with applicable local, state and federal regulations.

**Disposal Recommendations:** Product is suitable for burning in an enclosed controlled burner for fuel value or disposal by supervised incineration at very high temperatures to prevent formation of undesirable combustion products.

**Regulatory Disposal Information:** To the best of Royal Manufacturing Company, LP knowledge, this product is not regulated by CERCLA/RCRA as a hazardous waste or material.
