Under the terms of the 2019-2022 GUNITE/SHOTCRETE COMMERCIAL AGREEMENT WITH THE SOUTHERN CALIFORNIA DISTRICT COUNCIL OF LABORERS AND ITS AFFILIATE GUNITE LOCAL NO. 345, the Union is allocating the **July 1, 2019, \$2.15 per hour increase** as follows:

Wages	\$1.87
