4. HULK AND JUNK VEHICLES WILL BE IMPOUNDED DURING THE HOURS OF 8-5 M-F AND MAY BE SUBJECT TO A CHARGE THAT WILL BE REFUNDED IF THE REGISTERED OWNER REDEEMS THE VEHICLE.
