## New Medical Network: Aetna

As most of you are aware, we will be changing medical networks effective January 1, 2026. Aetna will be our new medical network and managed care administrator. We wanted to take a moment to answer some of the questions we have received.

### **Will my medical and mental health benefits be the same?**

Yes. Your benefits will not be impacted by the move to Aetna. You will have the same copays, deductible and co-insurance.

### **Will my prescription coverage be changing?**

No. Your prescription, dental, or, vision benefits will not be changing.

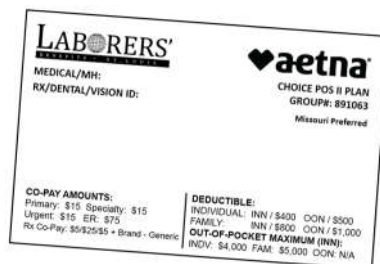
### **What is the name of the Member Assistance Program (MAP)?**

The Member Assistance Program (MAP) is called **Resources for Living**. You will continue to receive six free visits per issue, per year.

### **Can I still use Teladoc for telemedicine services?**

No. Beginning January 1st, your telemedicine services will be through **CVS Health Virtual Care**. Like Teladoc, **CVS Health Virtual Care** services will not be subject to copays, deductibles, or co-insurance.

By now you should have received your new insurance card. You will need to present this card to your doctor beginning January 1st. If you have not received your card or need additional cards, please call the **Benefit Office** at (314) 644-2777, ext. 2.

# NOVEMBER RECAP: Diabetes

The Centers for Disease Control and Prevention (CDC) estimates that **22.8% of adults with diabetes are undiagnosed.**<sup>1</sup> Diabetes left untreated, the high blood sugar can affect various organs in your body, putting you at higher risk of heart disease or stroke.

## EARLY SIGNS OF PREDIABETES

- Feeling more tired than normal, especially after eating.
- Hungrier or thirstier than normal.
- Skin Changes
- Minor cuts or scrapes are healing slowly.
- Weight changes without trying.
- More irritable or having trouble focusing.

If you are experiencing any of these symptoms or have a family history of diabetes, you should have an A1C blood test performed. The A1C test is a simple blood test that provides your average blood glucose (blood sugar) level over the past 3 months.

***Getting tested is simple!*** You can contact your primary care physician, and they can order the A1C blood test. If you don't have a Primary Care Physician, you can **call Marathon Health\* at (866) 808-6005**. You can even participate in the Laborers' Wellness Program and get paid \$100 for participating. Diabetes is one of fifty different conditions that are tested. ***See page 4 for more details on the Laborers' Wellness Program.***

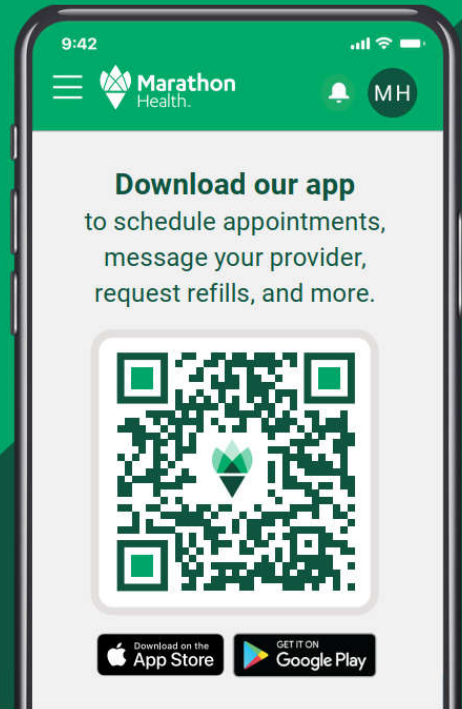

# APP Did you know we have a mobile app?

## Are you using the Mobile App? If you aren't you are missing out.

The mobile app allows you to have access to your health benefits at your fingertips as well as keeps you informed of important events and benefit news.

### Estimated Medical Costs

The mobile app allows you to also get an estimated cost of your medical procedure to help eliminate surprise medical bills. For example, if you are experiencing back pain and need to be seen by an orthopedic. You can search for an orthopedic physician in your area and see a list of common procedures with an estimated cost. Also, if your physician gives you a specific code, you can see if that procedure is covered along with the estimated cost.

- Verify Eligibility
- Find a Provider

The app will be available for all non-Medicare participants at no cost. If you have minor children, their information will be under the member. Spouses and adult children will need to create their accounts.
