



## 10-year Limited Warranty

Maxstone International, LLC warrants to the original purchaser that the Array Modified Acrylic Solid Surface Shower System products are free from defects in material and workmanship under normal use and service for a period of ten (10) years from the date of the sale. This warranty covers only products installed in accordance with the Array Shower Systems installation instructions, used as recommended, and not damaged due to misuse, abuse, or improper installation.

### Exclusion from coverage

This warranty does not cover:

- Minor conditions such as stains, scratches, water spots and burns which may be corrected as set forth in the care and cleaning instructions provided herewith;
- Slight color variations, which may be due to the unique properties of Array Solid Surface;
- Improper fabrication or installation;
- Damage caused by acts of natural disaster such as fire, flood, wind and lightning;
- Seams or changes made to the product by professional tradesmen or fabricators;
- Damages caused by unauthorized attachments and modifications;
- Damage during shipment;
- Any products moved from their original place of installation; or
- Any other abuses or misuse by the consumer.

### Repair or Replacement

If the purchaser discovers within the warranty period a defect in material or workmanship, after inspection by an authorized Maxstone representative, we will repair, or at our option, exchange the product for a similar model. Repair or replacement will be at the expense of Maxstone and shall include reasonable labor charges needed to repair or replace the defective products, but not removal, repair, or replacement of fixtures, hardware or decorative treatment. Maxstone shall not be liable in either tort or contract for any loss or direct, consequential or incidental damages arising out of the use or inability to use the Array Solid Surface product even if the manufacturer fails in its attempt to repair or replace the product.

### Transferability of Warranty

This warranty applies only to the original end-use purchaser and installation of these products in commercial or residential applications.

### Warranty Exclusion

THE FORGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANT ABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

Some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal right, and you may also have other rights which vary from state to state. No fabricator, installer, dealer, agent or employee of the manufacturer has authority to increase or alter the obligation or limitation of this warranty.
