Were you recently told you are not insured?

Did you recently have a visit with your provider (i.e., doctor, urgent care, etc.) and were told you are not insured? We received several calls from participants that were told this when they went to their doctor.

We have found that providers are confusing our group with the UnitedHealthcare Commercial Group; therefore, they are verifying eligibility under the wrong plan. We are NOT part of the commercial plan; we are a UnitedHealthcare Shared Service Group.

There are two ways providers can verify eligibility...

- 1) Call (888) 830-0179.
- 2) Visit the website, uhss.umr.com.

This information is also listed on the back (see below) of your insurance card. Keep in mind, this only applies to the participants covered under the Active or Non-Medicare group.



If you, the participant, are not sure if you are insured, you can verify your eligibility two different ways.



*In order to be eligible you must be fully vaccinated with a COVID-19 one shot or two shot dose.

In case you missed it...

Where are you working?

Last month, we asked an important question, "Where are your working?". This is an important question because the jurisdiction that you are working in is where your hours will be sent. If you are working outside of the St. Louis jurisdiction, your hours will be sent to the Home Fund in the area you are working in. For example, if you work in St. Charles County, your hours will be sent to the outstate Fund office located in Kansas City.

For hours that need to be sent back to the **Benefit Office**, you need to complete a Transfer Authorization form. This form can be found online, or you can request one to be mailed. Without this form, hours cannot be transferred back to your Home Fund, which will impact your eligibility and your pension.
