**NOTICE OF CLAIM FILING DEADLINE OF DECEMBER 10, 2020**

**PLEASE TAKE NOTICE**, that pursuant to the order entered on August 10, 2020, by the Circuit Court of Montgomery County, Alabama, Physicians Casualty Risk Retention Group, Incorporated ("Physicians") was placed into liquidation. The Order of Liquidation (the "Liquidation Order") was entered pursuant to Alabama Code § 27-32-7 (1975).

**TAKE FURTHER NOTICE**, that pursuant to the Liquidation Order, all rights and liabilities of Physicians and its policyholders, creditors and all other persons interested in their property or assets are fixed as the date of the Liquidation Order.

**TAKE FURTHER NOTICE**, that the Liquidation Order provides for the filing of claims and the setting of a claim filing deadline ("Claim Filing Order"). Pursuant to the Claim Filing Order, all persons, companies or entities who have, or may have claims against Physicians, their property or assets, or against a Physicians' insured or policyholder, shall have the right to present and file with the Receiver a proof of claim form on or before the claim filing deadline postmarked by **December 10, 2020**. Proofs of Claim must be accompanied by proper proof of loss, where required. You may obtain a proof of claim form online at <http://www.aldoi.gov> and <http://www.physicianscasualty.com>, or by contacting our office at (334) 240-7560.

**TAKE FURTHER NOTICE**, that any insured under an insurance policy by Physicians shall have the right to present and file with the Receiver a proof of claim setting forth a contingent claim on or before **December 10, 2020**. No such contingent claim shall be allowed for purposes of participating in any distribution(s) of estate assets that may be made, unless such claim has been liquidated and the insured claimant has presented to and filed with the Receiver evidence of payment of such claim on or before the contingent claim date of **December 10, 2020**. Any insured's contingent claim for which a proof of claim was received by the claim filing deadline of **December 10, 2020**, but which is not liquidated by **December 10, 2020**, may be estimated pursuant to Alabama Code § 27-32-26 (1975) for purposes of participating in any distribution(s) of estate assets, unless otherwise directed by the court.

**TAKE FURTHER NOTICE**, where to file claim. Proofs of claim, along with supporting documents, are to be filed with, and may be obtained from the Receiver. To avoid confusion, all creditor claims should be sent to the Receiver, Ryan Donaldson, Physicians

Casualty Risk Retention Group, Inc., P.O. Box 303353, Montgomery, Alabama 36130-3353. In order for a proof of claim to be timely filed, the Receiver must have physical possession of the proof of claim on or before the claim filing deadline, or the proof of claim form must have been delivered to the United States Postal Service for delivery to the Receiver and postmarked on or before the claim filing deadline with full postage prepaid, or the proof of claim form must have been delivered to a private mail courier for delivery to the Receiver on or before the claim filing deadline with delivery charges fully paid.

**TAKE FURTHER NOTICE**, the Receivership Court's liquidation order provides that all persons are restrained and enjoined from commencing or further prosecuting any action in law or equity or administrative proceeding against Physicians, except in this court; obtaining any preference, judgment, attachment, or other liens against any of the property, personal or real, of Physicians; commencing or continuing any action in the nature of an attachment, garnishment, or execution against any of the property, personal or real, of Physicians or its subsidiaries or their assets or any part thereof except in this court.
