## SECTION 4. FIRST AID MEASURES

**Eye Contact :** Immediately flush eyes with large amounts of water for at least 15 minutes. Get medical attention if irritation persists.

**Skin Contact :** To remove the material from skin, use soap and water . Discard contaminated clothing and shoes or thoroughly clean before reuse .



## SECTION 6. ACCIDENTAL RELEASE MEASURES

### Personal precautions, protective equipment and emergency procedures

**For non-emergency personnel :** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. ### Methods and material for containment and cleaning up

## SECTION 7. HANDLING AND STORAGE

### Precautions for safe handling

**Protective measures :** Put on appropriate personal protective equipment (see Section 8). Avoid breathing vapor or mist. Avoid contact of spilled material and runoff with soil and surface waterways. Avoid contact with eyes, skin and clothing. Do not ingest. Empty containers retain product residue and can be hazardous. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Do not reuse container. Avoid prolonged or repeated contact with skin. During metal working, solid particles from workpieces or tools will contaminate the fluid and may cause abrasions of the skin. Where such abrasions result in a penetration of the skin, first aid treatment should be applied as soon as reasonably possible. The presence of certain metals in the workpiece or tool, such as chromium, cobalt and nickel, can contaminate the metalworking fluid and as a result may induce allergic skin reactions. Evaporation of water from soluble cutting fluids during use may lead to

an increase in concentration which may result in the development of skin conditions due to irritation and defatting. It is important to monitor fluid strength on a regular basis with a refractometer and maintain it at the recommended concentration. Lubricants from other sources

and other contaminants should be minimized. Swarf and other debris should be removed. To maintain optimum performance and minimize bacterial spoilage, machine tool coolant systems should be cleaned on a regular basis.

**Advice on general occupational hygiene :** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. **Conditions for safe storage, including any incompatibilities**

Store in accordance with local regulations.
