HEALTH HAZARD DATA.

Inhalation: Remove patient to fresh air. Administer oxygen if breathing is difficult. Keep warm and quiet. Get medical attention.
Ingestion: Do not induce vomiting. Give patient milk or water to dilute. Immediately consult physician.
Medical Conditions Aggravated by Exposure: None generally recognized.
Chronic Health Hazards: Prolonged overexposure to solvent ingredients in section II may cause adverse effects to the liver, urinary, blood forming, cardiovascular, and reproductive systems.
