JOB DESCRIPTION:

This non-perm fulltime position serves a multitude of functions and will be required to operate all wage grade 54 equipment on the Parks Highway from MP 276-344, and can be requested to work on various crews under numerous Federally Funded projects. Tasks that could fall under this scope of work can include patching asphalt and gravel highway surfaces using 8-yard trucks, loaders, water trucks, rollers, sweepers and various smaller tools. Brush cutting utilizing machine mounted power brush cutting equipment. Crack sealing and crack banding using pickup trucks and torch wands. Hand brush cutting, hand patching, litter control, sign repair, flagging, guardrail and fence repairs, and drainage structures. A current and valid class A CDL with tanker and air brake endorsements is required.
