## General Vendor contract for all events

I will hold several events through the year and this contract will serve for all events at all venues unless otherwise stated. **All shows are non-refundable if a show has to be canceled by Blissful Boutiques, due to a catastrophic event or bad weather, your fees will be applied to the next scheduled show.**

**The fee for the Paseo Nuevo Makers Market is \$100.00 per event. The fee for Collection @RiverPark is \$120.00 per event. Fees for other events will vary.**

These venues do not provide tables, chairs or umbrellas (if outside). As we move from place to place I will update you on what you need to bring. In some cases, the venue will require certain set up. For example, if there are things required, you will be notified as to what you will need in order to participate. **UPDATE:** Starting spring of 2019, we will be using white table cloths for spring and summer and Black for fall and winter. If you do not have a white/black table cloths that go to the ground, one can be purchased from me for \$15.00 please let me know if you will need one. By agreeing to this contract, you are also agreeing to uphold the policies and procedures the venue and **Blissful Boutiques** requires. See below.

- 1) The undersigned agrees to obtain all necessary permits and city licenses prior to attending any **Blissful Boutiques** event and to have a copy(s) present in the booth at all times. You must also provide a copy to **Blissful Boutiques** with this application.
  - You will need a seller's permit which is issued by the California Department of Tax and Fee Administration: [www.cdtfa.ca.gov](http://www.cdtfa.ca.gov) or call 1-800-400-7115.
  - You will also need to obtain a city business license for the city you will be doing business in. SB City Business License: [www.santabarbaraca.gov](http://www.santabarbaraca.gov) or call 805-963-0611

- 2) The undersigned agrees to be present to sell only products they have made in person unless other arrangements have been made in advance, or our direct sales vendors.
- 3) **Effective January 1<sup>st</sup> 2018 all credit card transactions will be charged a 2.75% fee per transaction.**
- 4) **Initial payment of space fee is collected when application is turned in. Thereafter, the undersigned agrees to pay their space fee at the end of each show for the succeeding show. Please make sure you have cash, credit card or check on hand for payment. Unless other arrangements have been made with Blissful Boutiques.**
- 5) The undersigned agrees to maintain insurance on any vehicle that delivers vendors or goods to the event, and to provide proof to **Blissful Boutiques**.
- 6) It is recommended that each vendor maintains their own liability insurance at each event. By initialing paragraphs 12 and 13 and 14 you hold harmless Paseo Nuevo, The Collections @RiverPark and Blissful Boutiques from any/all loss, liability, charges and expenses if such occurrence should happen.
- 7) The undersigned agrees to comply with the City/County of Santa Barbara, City and abide by the rules and regulations of **Blissful Boutiques**. Failure to comply will result in immediate revocation of permit to sell at **Blissful Boutiques**. If this occurs, no refund will be given if permit is revoked for non-compliance reasons.
- 8) The undersigned agrees to notify **Blissful Boutiques** (805) 451-7147 as soon as possible if they will be absent from the event. It is under the discretion of Blissful Boutiques to allow as a one-time courtesy for your fee to be allocated the **next month's** event.
- 9) The undersigned agrees to pay initial set amount per venue. Forms of payment are: Cash, Check or Credit Cards. **Checks should be mailed to 6263 Aberdeen Ave, Goleta 93117** and the check should be made out to **LMG Vendor Events**. Any checks that are returned not honored by the institution they are drawn on will be subject to the penalty fee allowed by law. Cash can be delivered to the above address on or before the due date. Please see attached for credit card authorization form. **(Refer to paragraph 4 for ongoing participants.)**
- 10) The undersigned agrees to provide a sample of their work, whether a photo, Xerox, or actual item, to be juried for the **Blissful Boutiques** events, and to determine if it is appropriate for the event. If it is determined that the items being sold in the space were misrepresented, or not represented well by the sample(s) provided for jurying, the undersigned agrees to remove the item(s) in question immediately from display and the decision of the **Blissful Boutiques** Owner/Founder is FINAL on this.
- 11) I understand that this is a family oriented event and the following items will not be allowed to be sold by any vendor: wooden rubber band guns or other items that create a public safety hazard; pornographic material; or drugs. Any items judged by **Blissful Boutiques** Owner/Founder to be inappropriate for this venue will asked to be removed.

I have read a copy of the **Blissful Boutiques** rules, regulations and requirement, and agreed to abide by them at all times and to conduct myself and my business in a manner that is legal, safe and respectful of others and to require all of my employees and representatives to do the same. You must conduct ALL events in a professional, first-class and tasteful manner in accordance with the rules and regulations, as well as reputable business standards and practices. Vendors **must wear appropriate attire at all times while at the Shopping Center.** Vendors may not hawk or otherwise create a nuisance in the Shopping Center. No alcohol shall be consumed by any vendor during the hours of each show.
