### **INFORMATION FOR BIDDERS**

1. Sherry Mason, Municipal Manager/Clerk for the Borough of Beach Haven, Ocean County, New Jersey invites bids for **FURNISH AND INSTALL FENCING, VARIOUS LOCATIONS.**
2. Bids will be received by the Borough of Beach Haven at 11:00am on Tuesday, May 22, 2018, and will then and there be publicly opened and read aloud.
3. Bids forwarded to the Borough of Beach Haven before the time of opening of bids may be withdrawn upon written application of the bidders, who shall be required to produce evidence showing that he is or represents the principal or principals involved in the bid. Bids may not be withdrawn within twenty-four (24) hours of the stipulated time of opening of bids.
4. Bidders are cautioned not to attach any conditions, limitations or provisions to the bid, as such conditions may render their bid informal and may cause its rejection, unless otherwise noted in the specifications. The Borough reserves the right to reject any bid as incomplete that does not meet specifications.
5. Each bid must be submitted on a standard bid form supplied in the bid package and signed by the bidder or principal thereof and shall contain the name, address, email address and telephone number of the bidder. All prices and amounts must be written in ink. All erasures or corrections must be initialed by each signatory to the bid. Each bid shall be contained in a sealed envelope addressed to the Municipal Clerk and shall specify the item for which the bid is submitted and must be delivered on or before the time set forth in the advertisement at the place stipulated. The Borough will not be responsible for bids forwarded through the mail if lost in transit at any time before bid opening.

6. Unless otherwise stipulated in the specifications, the bid must be accompanied by:

**a. Bid guarantee (bid bond, certified or cashier's check)** to the order of the Borough of Beach Haven for ten percent of the amount of the bid. The guarantee used may not exceed \$20,000.00.

**b. Consent of Surety**

**c. Non-Collusion Affidavit**

**d. Disclosure of Investment Activities in Iran**

**e. New Jersey Business Registration Certificate**

**f. IRS form W9**

**g. Affirmative Action information**

**h. Employee Information Report**

7. Bid guarantee will be returned to all except the three (3) apparent low bidders within ten (10) working days after the opening of bids. The remaining bid guarantees, except that of the bidder to whom the contract is awarded, shall be returned within three (3) working days of the date of the contract award. The bid guarantee of the bidder to whom the contract is awarded shall be retained until the contract is executed and the goods are delivered and accepted. If bid proposals are rejected, the guarantees of all bidders will be returned within five (5) working days thereafter.

8. More than one (1) bid from an individual, a firm or partnership, corporation or association or principals under the same or different names shall not be considered. Bids which are obviously unbalanced may be rejected at the option of the Borough.

9. The right is reserved to reject any or all bids in accordance with N.J.S.A.40A:11-13.2 for reasons stated therein and to cancel or terminate a contract anytime the vendor is in non-compliance with the bid specifications.

10. The attention of the bidders is especially directed to the provisions of federal, state, county and municipal law, statutes and regulations that may apply. All pertinent laws, statutes, ordinances and regulations shall be obeyed and complied with.

11. Bidders are required to comply with the requirements of N.J.S.A.10:5-31 and N.J.A.C. 17:27

12. Bills are publicly approved the second Monday of each month at regular meetings of the Municipal Council. All bills approved at that meeting are paid by check and are mailed from the Finance Office within five (5) days. All vouchers submitted for payment must be in the Finance Office by 9 a.m. on the Wednesday preceding the Monday meeting.

13. The successful bidder shall indemnify and save the Borough of Beach Haven harmless from and against all suits, claims, actions or judgments for any injury or damage sustained or alleged to have been sustained by any party or parties by reason of the use of defective materials furnished and delivered under the contract to the awarded to the vendor or by or on account of any act or omission or commission of any contract, and in case any such action shall be brought against the Borough of Beach Haven, the contractor shall immediately take charge of and defend such action and charge the expense of same to the contractor. Upon execution of a contract, successful bidder will furnish a Certificate of Insurance to the Borough naming the Borough as additionally insured.

14. Manufactured products, manufactured in the United States, whenever available shall be used.

15. No deposits or prepayments will be accepted as condition of acceptance of award.

16. N.J.S.A.40A:11-13 requires that any challenges to bid specifications must be submitted to the Municipal Clerk no less than three (3) business days prior to the bid opening. Challenges filed after that time will not be considered.

17. Bidders should be aware that N.J.S.A.40A:11-4 allows in part for the governing body of a contracting unit to disqualify a bidder who would otherwise be determined to be the lowest responsible bidder, if the governing body finds that it has had prior negative experience with that bidder.

18. N.J.S.A.19:44A-20.27 requires that any business entity receiving in any calendar year \$50,000.00 or more in public contracts with public entities must file an annual report with the Election Law Enforcement Commission (ELEC).

19. If a contract is to be awarded, it will be awarded to the lowest responsible bidder whose evaluation by the Borough indicates to the Borough that the award will be in the best interest of the Borough. The Borough reserves the right to award the bid to more than one vendor when it is deemed to be in the best interest of the Borough to do so. The Borough reserves the right to award the contract to different vendors for certain sections of the bid specifications.

20. The fencing sites are available for inspection by calling the public works department for an appointment.

#### I ----- Furnish & Install: Taylor Avenue Basketball Court

Borough will remove existing chain link fence.

All chain link fencing should be 9 gauge, 2" mesh, green vinyl coated.

1. (283') of 10' high chain link, to be installed on existing schedule 40 galvanized posts
2. Replace top, middle, and bottom rails with schedule 40 galvanized pipe, including hardware
3. (66') of 6' high chain link fence with schedule 40 galvanized top, middle, and bottom rails and schedule 40 galvanized posts, set 3' below grade level with cement footing
4. (1) 6' high walk gate, chain link, on schedule 40 pipe, including hardware
5. Install galvanized tension and brace bands for all connections
6. (5) 4" caps

#### II----- Furnish & Install: Various Gates for Borough Yards

All chain link fencing should be 9 gauge, 2" mesh, black vinyl coated.

1. (4) sliding gates for a 20' wide opening that are 6' high aluminum frame chain link fence on internal roll system. 4" schedule 40 galvanized posts set 3' below grade level with cement footing
2. (1) 20' wide by 6' high double drive swing gate, gate shall be 2" galvanized framing and black vinyl coated 2" X 9 gauge chain link fence. 4" schedule 40 galvanized posts set 3' below grade level with cement footings, includes (2) 48" drop rods
3. Supply all hardware needed for installation

#### III ----- Furnish & Install: Beach Haven Elementary School

All chain link fencing should be 9 gauge, 2" mesh, black vinyl coated.

1. (650Lf.) Remove fence complete
2. (650Lf.) of 6' high chain link fence, including rails & appropriately sized posts set 3' below grade level with cement footings
3. (2) swing gates for a 4' opening, with 6' tall, chain link fence including appropriately sized schedule 40 galvanized posts set 3' below grade level with cement footings
4. (2) sliding gates with a built in man entrance for a 20' opening, with 6' tall, chain link fence including appropriately sized schedule 40 galvanized posts set 3' below grade level with cement footings
5. Supply all hardware needed for installation

**\*Any surface disturbed by installation must be returned to its previous condition.\***

**GOODS, PROFESSIONAL SERVICES AND GENERAL SERVICE

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex.
