



Public Employees - Local 71 **SCHOLARSHIP & TRAINING FUND** Guidelines

Through the generosity of the Local 71 Scholarship & Training Fund and Public Employees Local 71, a self-perpetuating fund will provide a program of scholarships to assist eligible individuals in furthering their professional training, certifications, licenses, and education.

You may be eligible to receive one of the scholarships awarded through the Local 71 Scholarship and Training Fund if you meet the eligibility and application requirements set forth below.

Eligibility Requirements

1. Applicants must be a member or a dependent, including grandchildren, of a member in good standing with Public Employees Local 71 for no less than 1 year.
2. Applicants must either be enrolled in a training or educational program or demonstrate that they will be enrolled in a training or educational program within 12 months, otherwise approved scholarships that are not paid out within 1 year from approval date will be null/void.
3. Once you receive a scholarship, you may not reapply for one calendar year.

Application Requirements

1. Please type or print clearly with a blue or black pen.
2. You must complete the entire 3 page scholarship application form. If information is not applicable, please note "NA" in any unanswered section.
3. Submit two (2) letters of recommendation from people **not related** to you with your application. It is preferred that one (1) letter come from an educational facility, training facility, or current supervisor.
4. Current employees will submit their most recent performance evaluation, if applicable.
5. Applicants will submit a course description for the training or educational program in which the applicant is enrolled or will be enrolled within 12 months.
6. Applicant must submit the training program or educational program's W-9 form, you may get this form from the educational programs billing/financial department.

Application Procedure

The exact nature and content of the scholarship program will be determined on an annual basis by the Executive Board. The Fund will announce the scholarship recipients by letter and/or phone. Your name may be published in our Annual newsletter, Local 71 Facebook page and at Local71.com

The Local 71 Scholarship and Training Fund does not discriminate based on any protected categories in the selection process or the administration of the scholarship program.
