JOB DESCRIPTION:

Protect the safety of the general public from injury or death resulting from inadequate electrical installations through inspection of projects governed by the Joint Pipeline Office (predominately the Trans-Alaska Pipeline).

Responsible for enforcement of the codes adopted by Alaska Statute 08.60.580 in regards to electrical installations.

Inspector is responsible for scheduling inspections with contractors and pipeline owners and operators. These inspections include scheduling travel, inspection activities, providing written inspection reports and Notice of Violations.

This position is extremely unique in that while assigned to DOLWD the incumbent will work on a daily basis directly for the State Pipeline Coordinator and work side by side with both state and federal JPO staff. This position is the primary advisor to the State Pipeline Coordinator for matters falling within the scope of the adopted National Electrical Code and must be able to clearly communicate both verbally and in written communication. This position requires someone with public speaking ability who is comfortable speaking in front of both small and large groups.

The position requires an individual who can maintain a professional relationship with pipeline service companies from the executive level to the tradesman on the various construction projects.

Frequent travel is required to remote sections of the Trans-Alaska Pipeline between pump station 1 and the Valdez Marine Terminal.

Experience working in the oil and gas industry is highly desirable.

SPECIAL REQUIREMENTS:

Valid driver license is required. Must hold current Certificate of Fitness as Journeyman Electrician.

THIS POSITION REQUIRES THE INCUMBENT TO OPERATE:

Must be able to operate State Equipment Fleet light duty vehicles. Telephone, cellular phone, fax machine and copier.
