

MARKET UPDATE: LOS ANGELES, CA Single Family Homes

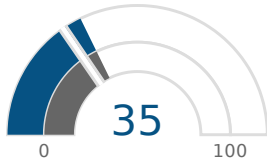
(as of Monday, December 31st, 2018)

This week the median list price for Los Angeles, CA is \$1,150,000 with the market action index hovering around 35. This is about the same as last month's market action index of 35. Inventory has held steady at or around 1755.

MARKET ACTION INDEX

The Market Action Index answers the question "How's the Market?" by measuring the current rate of sale versus the amount of the inventory. Index above 30 implies Seller's Market conditions. Below 30, conditions favor the buyer.

Slight Seller's Advantage

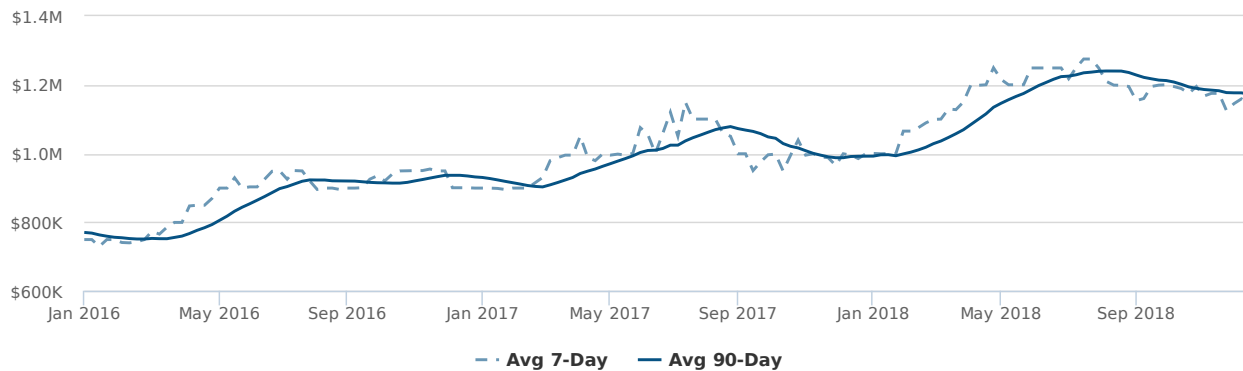
In the last few weeks the market has achieved a relative stasis point in terms of sales to inventory. However, inventory is sufficiently low to keep us in the Seller's Market zone so watch changes in the MAI. If the market heats up, prices are likely to resume an upward climb.
