# Figure & Portrait Juried Exhibition

Art & Sol Studios is proud to announce their 1st Annual "Figure & Portrait" Juried Art Exhibition for the month of July 2016. We encourage entries from all 2D/3D artists regardless of their experience or education in the art field. This is an international competition and everyone is encouraged to participate. Artists should submit their best representational and non-representational art related to the "Figure & Portrait" theme. This competition will be judged within three categories; Paintings, Photography and Mixed Media and 3D Work. Awards will be given for the Best of Show, 2<sup>nd</sup> Place. In addition, depending on the amount and the quality of all submissions received, Honorable Recognition awards will also be presented.

### Eligibility:

- •Must be original work to the artist.
- •The artist must be willing to sell their work (print or original).
- •All work must be available in both low resolution as well as high resolution form. For the purposes of this competition, low resolution files should be sent and not exceed 10 MB. High resolution files will be required for print media for which your work may be selected.

#### Timeline:

- •Deadline for Receiving Entries: June 30, 2016
- •Competition Results are Posted: July 4th, 2016
- •Artwork Received By: July 11th, 2016
- •Opening of Juried Art Exhibition: July 18, 2016-August 1, 2016
- •Award Certificates Emailed to Artists: August 1, 2016
- •Artwork shipped back to artists: August 5, 2016

## **Entry Fees:**

- •\$40 for all images up to 3
- •\$15 for all images after

#### **Prizes:**

Best of Show Receives \$500 Cash Reward, 2<sup>nd</sup> Place Receives \$200 Cash Reward, Honorable Mentions Receive Certificate Awards and \$50 Utrecht Art Supply Gift Cards

Image Preparation: Digital images only are accepted.

If the artwork to be entered is more than 8" on any side, please size the image so that the longest side measures at least 2400 pixels but no larger than 3600 pixels with 300 dpi resolution.

If the actual size of the artwork is smaller than 8" on its longest side, the image should be at it's actual size at 300 dpi resolution.

Name the files: Your lastnamefirstinitial\_titleofpainting (i.e. smithj\_spotthedog). All lower case: Do not put spaces between words in the title. Y Save the files as a .jpg or .jpeg file at "high" or "maximum" quality (9, 10, 11 or 12). (Hint: If the file size ends up being less than 1MB, it won't be acceptable.

Any images that do not meet these specifications may be disqualified and discarded without being considered by the jurors. Images should ONLY be of the artwork - do not include matting, frame, etc. in the image – in focus, uniformly lighted and undistorted by camera angle etc. These are the images that will be used if your art is selected for the exhibit book and website: Be sure they are good!

No slides, photographs and/or printouts. Only .jpg images conforming to these standards will be considered and must be submitted online per instructions posted here.

**Entries:** Only online submissions are accepted: Mailed or delivered entries on CD/DVD/flash drives are NOT accepted. Artists May enter all artwork, Art & Sol Studios will make selections based on collection. Membership fees can be found on the website.

**Preliminary Jurying:** Selection of finalists will be based on digital images. Finalists will be selected by a committee of qualified art professionals. Awards Jurors will be respected, highly qualified artist/instructors, curators or collectors of note. Awards Juror(s) will view the work exhibited in the gallery to make their award selections. Images submitted must represent the actual work to be delivered to the gallery. Art & Sol Studios reserves the right to withhold awards if jurors deem submitted entries to be below minimum standards of excellence. Jury decisions are final.

**Exhibit Catalogs:** We anticipate that we will publish a full-color hard-cover book catalog of entries submitted to this competition (finalists, alternates and a selection of other meritorious entries).

**Presentation (for in-gallery exhibits only):** All entries must be suitably framed and wired for hanging (no clips or sawtooth hangers). Gallery-Wrap canvas or cradled panel is acceptable as long as the sides are neatly painted/finished. No staples can be visible on the sides of the canvas. Any work with inadequate, improper or damaged framing may be returned to the artist without being hung in the show or considered for awards at the gallery director's discretion.

**Delivery/Shipping (for in-gallery exhibits only):** Works on paper must be framed and glazed (Plexiglas recommended). Finalists will ship or deliver works to Art & Sol Studios for the Awards Exhibit. Shipped work must be sent in a reusable container. The artist is responsible for the cost of shipping to and from Art & Sol Studios. Pre-paid labels or a credit card number for return shipping must be included in the shipping container with the artwork. INTERNATIONAL ARTISTS ARE RESPONSIBLE FOR ALL CUSTOMS CHARGES/DUTIES and the appropriate forms for the return of their artwork must be included in the shipping container.

**Sales:** Work needs for sale to be eligible for the exhibition. Art & Sol Studios will make every effort to encourage sale of work available for purchase. Finalists will receive a consignment agreement. Art & Sol Studios will retain a 30% commission for all sales of work from this exhibition. Payment for sales will be mailed to the artist within 30 days of the close of the exhibit. Liability: For in-gallery exhibits, Artists should insure their hand-delivered or shipped work, Art & Sol Studios, LLC
