ORDINANCE #2018-10C

AN ORDINANCE AMENDING Chapter 27, “Personnel,” of the “Code of the Borough of Beach Haven, County of Ocean, State of New Jersey” as it pertains to Group Medical Insurance waivers

WHEREAS, the governing body wishes to eliminate payments to eligible employees waiving insurance coverage.

NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO HEREBY ORDAIN:

SECTION I

Chapter 27-18, “Group Medical Insurance,” of the Code of the Borough of Beach Haven, shall be amended as follows (underscores represent additions; ~~striketroughs~~ represent deletions) renumbering as necessary:

~~3. Any employee who is eligible for coverage elsewhere as a dependent may opt to waive his or her coverage. In consideration of this waiver, each year the Borough will pay the employee 25% or \$5,000 whichever is less, of the amount saved by the Borough.~~

~~4. An employee who waives coverage will be permitted to resume coverage, if necessary, provided that any advance payment for the waiver of coverage is repaid on a pro rata basis.~~

3. The Borough shall not provide any payment to any employee for opting to waive his/her health coverage. Pursuant to N.J.S.A. 40A:10-17.1, The decision of a municipality to allow its employees to waive coverage and the amount of consideration to be paid therefor shall not be subject to the collective bargaining process.

SECTION II

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Borough Clerk is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

SECTION III

If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION IV

This Ordinance shall take effect on January 1, 2019 upon publication thereof and after final passage according to law.
